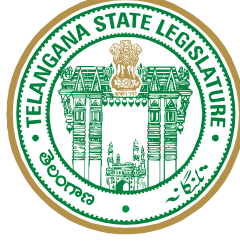

Assembly has passed the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement (Telangana Amendment) Bill, 2016 on 28th December, 2016. The Governor has referred the Bill for the assent of the President of India. The President of India referred the Bill to the Home and Law Ministries and they suggested certain amendments. With your permission I beg to move the official amendments given notice of and request the House to approve the same.
